

Course Name: Safety & Health Instructor

Duration: 0.00 **CEUs:** 1.20 **Description:**

This Instructor Trainer program is a hands-on course designed for individuals wanting to provide quality safety and health programs in their local communities as the Instructor. Students participating in this course must first complete the Train the Trainer online program before entering this course. Participants in this program will learn how to develop lessons, teach first responder skills, and create meaningful outcomes that cater to all learning styles and incorporate adult learning concepts. Safety & Health Instructor Candidates are required to perform two teaching demonstrations with topics from the Safety & Health programs. Candidates are expected to apply newly, acquired instructional teaching concepts both from the Train the Trainer program and this class into their teaching demonstration assignments. Upon course completion, participants will become certified as Safety Health Instructors making them eligible to teach all E&A Safety & Health programs for: Standard First Aid, Community CPR & AED, Healthcare Provider Basic Life Support, and Preventing Bloodborne Pathogens programs at both the first responder and community layperson student levels. Instructor level grants teaching authorization for OSHA workplace requirements for medical content for workplace CPR/AED & Standard First Aid training. It is ideal for individuals seeking job-site certification requirements, as well as those simply desiring to how to teach others as the provider for healthcare provider level and community basic level lifesaving skills and information on medical emergency services. The content in the course is defined by the International Liaison Committee on Resuscitation (ILCOR). and is promulgated through the most recent publication of the "CPR and ECC Guidelines" by the American Heart Association. Participants receive the most current content through a variety of educational methods and demonstrate competency in required lifesaving skills on manikins and through simulations, drills and exercises to earn certification in order to qualify as an Instructor of the program.

Audience:

Program is designed for participants who are competent in Safety & Health program content and who have demonstrated a thorough understanding of the program content they will be teaching, the ability to properly demonstrate and remediate all skills and how to most effectively deliver the program. This program is designed for individuals seeking to become a first time certified Instructor or individuals who may have not met the standard to receive reciprocity from prior teaching credentials from E&A's National Office.

Prerequisites:

- All participants in this program must first complete the two hour Train the Trainer online program prior to starting this course.
- Instructors are those who have been certified by ITs to teach provider level courses.
- Instructors must be 18 years of age or older and have completed the Instructor course or been granted reciprocity by the E&A national office. To retain Instructor certification, instructors much teach 1 class per year.
- Safety & Health Instructors must possess a thorough understanding of the content of the courses they will be teaching by demonstrating compentency in the skills.
- Must be able to perform the skills at an ability that properly demonstrates the skils they are teaching.
- Must be able to demonstrate an ability to properly remediate all skills when a learner they are teaching is unable to perform a skill properly.
- Are required to know how to most effectively deliver the course using course materials.

- 8. Demonstrate the ability to properly utilize audiovisual devices when teaching a course.

Expectations:

Be prepared to demonstrate all healthcare provider and layperson First AID, CPR and AED skills for competency on first day of the scheduled class.

Complete the Ellis Education Services online Train the Trainer module before the first scheduled class. Topics from that program will be incoporated into the live portion of this program. Students must have the online module completed prior to entering the Safety & Health Instructor Class.
